#### PRODUCT AND IDENTIFICATION

Product Name - Tallow Bound, Pure & Simple, Pozilime, Interlime Limewashes.

Intended Use - As a decorative and weatherproofing finish for use on lime renders and previously limewashed surfaces.

#### COMPOSITION/INFORMATION ON INGREDIENTS

Water based pigmented and unpigmented limewash. Tallow, linseed oil, PVA & salt as additives in varying foundations.

#### HAZARD IDENTIFICATION

Contains CALCIUM HYDROXIDE

R38 Irritating to skin

R41 Risk of serious damage to eyes

#### FIRST AID MEASURES

Eye Contact: Remove glasses / contact lenses, irrigate eye with copious amounts of water for 10 minutes & seek medical help.

Skin Contact: Clean skin with proprietary cleaner and wash with soap and water. Remove heavily soiled clothing.

Ingestion: Do not induce vomiting - seek medical help immediately.

## ACCIDENTAL RELEASE MEASURES

## HANDLING AND STORAGE
